<b>5. MINIMUM ENTRIES</b>				
<b>5.1</b>	8 is the minimum number of pre-entries which must be received for each Competition Group.			
<b>5.2</b>	If insufficient entries are received for a Competition Group to form in its own right, the Competition Group <u>will be</u> consolidated in accordance with the Competition Rules Chapter 1 – Rule 9.

<b>1. FORMAT OF RACING – CLUB COMPETITION GROUPS - Format 3</b>		
1.1	Qualifying	One 4 minute session – Qualifying will determine grid positions for Heat 1 & 2 – with fastest time on Grid 1, and so on
1.2	Heats 1 & 2	8 Laps each – Results from Qualifying – Fastest to the front for Heats 1 & 2
1.3	Heat 3	8 Laps – Points from Finishing Positions from Heats 1 & 2 – lowest points to pole and so on
1.4	Final	13 Laps – Final Only Counts – Finishing Positions from Heat 3 to Pole and so on

<b>3. KART RETRIEVAL</b>		
3.1.	Pit Crew with trolleys Will Not be given access to the Circuit during Qualifying and Racing.	
3.2.	Retrieval of Karts is at the discretion of the Clerk of the Course	
3.3.	Pit Crew must only enter the Circuit when permitted by the Grid Marshal or the Clerk of the Course and then only if wearing a <b>HIGH VISIBILITY SAFETY VEST</b> on the upper torso.	

4.	<b>ADDITIONAL VENUE REQUIREMENTS</b>
4.1.	Subject to any applicable laws which may govern the access of animals, including but not limited to guide dogs, no animals are allowed anywhere within the facility.
4.2.	No dumping of Fuel or Tyres, please make your own arrangements.
4.3.	No unlicensed driving of motor vehicles permitted at the Circuit.
4.4.	No motorised scooters, mini bikes, roller blading, skateboards, bicycles and tricycles allowed at the complex during the entire Meeting. Officials may confiscate any such items for the duration of the Meeting.
4.5.	Marquees are not to be erected without consent of the Club.
